1. The personal data shall be processed with the consent only for the duration of the consent granted (with the proviso that in the event of non-use of the services of the Club for a period of 12 months of the last visit to the Club, the personal data shall be automatically erased, because it shall be deemed to be the resignation from the membership of the Club).
2. Your personal data may be disclosed by PDC:
  - to employees / associates of PDC authorised to process thereof on the instruction of PDC for the purposes indicated in the consent,
  - to entities whom PDC entrusted the processing of personal data to the extent necessary to act in a proper manner, including: technical and organisational services providers, in particular to providers of ICT services for the benefit of PDC, with maintaining the guarantees required by law and ensuring the security of data,
  - institutions acting and authorised by operation of law.
3. Granting consent for the processing of personal data is voluntary.
4. You have the right of access to the content of your data and the right to have them rectified if they are inaccurate.
5. You have the right to request, at any time, that the data be erased or their processing restricted, the right to data portability, to object to data processing, and to withdraw, at any time, the consent for the processing of data.
6. The withdrawal of consent shall be effected by sending an e-mail to the e-mail address indicated above or by mail to the address as specified above, or through filling out the form provided below and delivering it to PDC. The withdrawal of consent shall cause immediate cessation of the processing of your personal data and their erasure by PDC.

Such withdrawal shall not affect the lawfulness of the processing which took place prior to the withdrawal.

7. PDC has no intention of transferring your personal data to recipients located outside the European Economic Area (EU countries and Iceland, Norway, and Lichtenstein).
8. You shall not be subject to decisions made by automated means (without human involvement).
9. Your personal data with regard to the frequency of the use of services shall be profiled for the purposes of developing an adequate offer of services for you and special offers available to the Members of the FitPark Club.
10. You have the right to lodge a complaint with the President of the Office of the Personal Data Protection (or another competent supervisory authority), if you find that the processing of personal data by PDC infringes the applicable provisions of law, in particular those of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: "GDPR").

PDC ensures the data protection measures in accordance with the applicable provisions, in particular pursuant to GDPR.
